

Directions to Northern Illinois Brace Club in Roscoe, Illinois

From I-39 /I-90, go to Rockton Road (Exit #3). Go East on Rockton Road to County Line Road (second stop sign). Take County Line Road South to Elevator Road (first stop sign). Go West on Elevator Road .3 miles. NIBC will be on the North side of Elevator Road.

From I-43 go to Highway 140 (Exit #6). Go South on Highway 140. After about 5 miles Highway 140 curves at the State Line and becomes Highway 76. Continue for 4.5 miles to Hunter Road. Take Hunter Road to the West (right) for about 6 miles to NIBC on the North side of Elevator Road (Hunter Road becomes Elevator Road at the County Line .3 miles before NIBC).

RULES AND ADDITIONAL INFORMATION

ABSOLUTE. "Absolute is a competition held for the winners of all regular classes at an AKC licensed or member Dachshund field trial. It may be awarded at any field trial that offers both Open All Age and Field Champion stakes. The running procedure for Absolute shall be at the discretion of the field trial committee and shall be specified in the premium list. Bitches that are in season, as determined by the field trial committee, are ineligible for Absolute if there are any male class winners competing. Absolute may be withheld for lack of merit but not for lack of competition. The AKC criteria for eligibility to judge is defined in "Field Trial Rules and Standard Procedure for Dachshunds", Chapter 5, and shall be applied to the selection of judges for Absolute. The judges for Absolute may either be advertised in the premium list or selected the day of the trial by the field trial committee." DCA Board of Directors, October 14, 2017

Four Absolutes will be held during HMC 2020. The following applies to all Absolute competitions during the Harvest Moon Classic: Absolute is a competition, not a stake or "nonregular" class. Absolute will be held immediately following the conclusion of all regular stakes, if possible. If it is not possible to hold the competition as scheduled, the field trial committee shall announce and post when the competition will take place. The FIRST place winners of each regular stake are eligible for Absolute unless they are ineligible to compete under the actual judges. Bitches that are in season, as determined by the field trial committee, are ineligible to compete against any males. Participation in Absolute shall be voluntary, not mandatory. All handlers of dogs eligible to compete for Absolute must keep themselves informed of the progress, conclusion and location of the final stake of the day and be present with their eligible dog within 15 minutes of the conclusion of that stake, or they shall be determined to have voluntarily withdrawn from competition. Two judges shall be selected from that day's judging panel, if possible, and their names shall be posted in the clubhouse after 2nd series of the last stake of the day is announced. If it is not possible to secure judges from that day's judging panel, the committee shall select additional judges, as needed, in accordance with AKC rules and procedures. To determine the Absolute Winner, Brace 1 shall be Open Dog Winner vs. Open Bitch Winner, followed by Brace 2, which shall be FC Dog Winner vs. FC Bitch Winner. Winners of Brace 1 and Brace 2 shall compete for Absolute Winner. If a brace is incomplete, or becomes incomplete, the remaining dog may continue to compete. Absolute may be withheld for lack of merit, but not for lack of competition.

APPRENTICES. Anyone interested in apprentice judging during HMC should contact the HMC Coordinator, to discuss availability and options.

BEATING BRUSH. Everyone needs to contribute to the success of the trials in some way. Beating brush is an essential part of field trialing, and the trial cannot be conducted without brush beaters. If you are unable to beat brush, please find another way to contribute! There are numerous clubhouse chores that need attention for those unable to be in the field.

CAMPING. Overnight camping is available at the grounds. Reservations will be accepted for 9 units at \$20 per night for camping with water & 30 amp electric hook-ups. Reservations will be accepted for up to 20 units at \$15 per night with 110 v electric-only hook-ups. If you "might" want electricity (temperature or other considerations), it is suggested you make your reservation for an electric-only space, however refunds will not be made if the hookup is not used. Reservations will be accepted for sites without hook-ups at \$10 per night - reservations for sites with "no hook-ups" will not have hook-ups. One camping unit per space.

Reservations must include payment and must be received by September 23rd. REQUESTS FOR CAMPING SPACE MADE AFTER SEPTEMBER 23rd MUST BE MADE BY EMAIL OR TELEPHONE WITH CHERI FAUST AND WILL NOT BE ACCEPTED VIA US MAIL. Judges, Event Chairs and

Secretaries will be considered first, and requests for all event days may be given priority over shorter stays. Reservations that cannot be accommodated will be refunded/returned. Cancellations received before September 23rd will be refunded. Cancellations after September 23rd will receive a refund less one day's reservation fee. Early departures will not receive a refund. Extra day extensions should be paid at the time they are requested. The CAMPING RESERVATION REQUEST FORM is in the premium list. Please note that clubhouse "camping" is not available for these trials.

CAMPERS MAY NOT ARRIVE OR DEPART during quiet hours (10:00 p.m. - 7:00 a.m.) except in an emergency situation.

Camping spaces will be assigned by September 28th via email. Spaces may not be shared, exchanged or otherwise changed without permission.

A shower is available in the clubhouse and will be available from 30 minutes after the conclusion of awards until 7:00 a.m. each day. Bring your own towels. *As a COVID precaution, you may not leave wet towels hanging in the clubhouse to dry – please take them with you. If you use the shower, you must spray the shower stall with disinfectant that will be provided. Masks are not required in the shower.

EARLY ARRIVAL (prior to noon on Thursday 10/3) AND LATE DEPARTURES (after noon on Monday 10/14) are possible, but must be arranged in advance with Cheri Faust.

CLUBHOUSE. No dogs allowed in the clubhouse. Washing dog dishes in the kitchen sink of the clubhouse is not allowed – please use the outdoor sink (preferred) or the bathroom sink, if necessary.

DOGS WAITING IN THE FIELD. Dogs on carts, dogs crated in the field or otherwise waiting to run must be kept QUIET and not be a distraction. Tethering of dogs to the fence is NOT allowed.

ENTRIES. Pre-entry will not be accepted for these trials. Entry forms must be complete, legible and submitted on a regulation 5 $\frac{1}{2}$ " x 8 $\frac{1}{2}$ " form. A separate entry form must be submitted for each dog for each trial entered.

*As a COVID precaution, please give your entries and fees to the secretary, then leave the area. Do not congregate around the secretary's table! Please make checks payable for entry fees as indicated on the JUDGING ASSIGNMENTS AND RUNNING ORDER page. If paying in cash please bring the correct change to avoid an exchange of money. FYI - The Secretary's table might be in the pole barn.

ANYONE that has EVER had a check returned to Madison Area Dachshund Club for insufficient funds (you know who you are) shall be on a cash-only basis for entries made at the Dachshund Club of America, Dachshund Club of the Great Lakes and Madison Area Dachshund Club field trials. Any check issued to Badger Dachshund Club that is returned for insufficient funds will be subject to a \$35.00 penalty payment in addition to the actual amount of the check. Cheri Faust, Northern Illinois Brace Club, Minnesota and Madison Area Dachshund Clubs reserve the right to charge any bank fees incurred, in addition to the actual amount of the check.

FIELD MARSHALS. If you are willing to marshal, please let the HMC Coordinator know what stake(s) will work for you. Marshals will be confirmed day-of-trial.

FOOD. Breakfast and Lunch will be available at the trials. Advance reservations are not required. You must sign up at roll call for lunch since meals will be individually packaged. If you have special needs/diet requirements, please plan accordingly. *As a COVID precaution, please pick up your breakfast or lunch in the clubhouse, then proceed outside to eat (weather permitting). Inside seating will be limited to 50% of capacity (20 seats).

"Wild Thing" dinner – Saturday, October 10, 2020 in the clubhouse. *As a COVID precaution, this will NOT be a potluck as in past years. All food will be provided by Cheri Faust. If the weather cooperates we may be eating by the campfire.

If you prepare evening meals in the clubhouse, you may use any of the hardware (pots, pans, etc.), but you are <u>required</u> to <u>bring your own</u> paper goods (paper towels, paper plates, plastic ware, etc.) or make a donation for same. You MUST clean up and PUT AWAY after yourself. Do not leave leftovers in the refrigerators – they will be disposed of without notice! *As a COVID precaution you must disinfect any area used (kitchen counter, tables eaten at, etc.) Cleaning products are provided. Clubhouse seating limited to 20 persons at one time.

Please don't take, borrow, use or serve food that you did not bring. No refrigerator space will be available in the clubhouse, except for medications which should be clearly marked with the owner's name.

HARNESSES. The AKC rules are silent regarding the use of body harnesses. As a result, body harnesses will only be allowed if the handler receives advance permission of both judges for the class. By field trial committee rule, the harness must be well fitting with nothing hanging from it and with no attachments other than tags for identification purposes and the harness must remain on the dog the entire time the dog is under judgment.

HMC LOGOWEAR. A limited number of items will be available for sale at the trials. First come, first served. Additional logowear is not available – when it's gone, it's gone.

MOTORIZED VEHICLES. Golf carts and utility vehicles may be utilized during the trial. See "allowable drive area" map in the premium list.

NOISE. This is a residential area and respect for others in the area is required for use of these grounds. The barking of dogs must be kept under control at all times. Dogs may not be left unsupervised in x-pens. "Quiet hours" are from 10:00 p.m. until 7:00 a.m. During quiet hours the use of outside lights and noise must be kept to a minimum.

NO SMOKING. Smoking is prohibited on the NIBC and Garard properties, including in the clubhouse, parking/camping areas or on the running grounds.

PRACTICE. The Club(s) participating in the Harvest Moon Classic may allow event participants to practice on the grounds following their field trial(s). Practice may be suspended by an NIBC Officer, if necessary, due to stress on the rabbits, excessive damage to ground cover, the Club(s) failing to enforce running grounds rules, or other conditions deemed to be in the best interest of maintaining the grounds for field trials. The Club(s) will enforce the following rules and will exclude violators from further practice without additional warning:

- 1. One dog at a time loose on the grounds, per handler. Each dog must be with a handler. Taking an extra person that is not actually handling a dog does not allow one handler to run multiple dogs.
- 2. Dogs must be under the control of the handler while on the grounds, and handlers will not allow a group of dogs to "pack hunt".
- 3. If any rabbits are killed or injured during practice, handlers will report it to an NIBC Officer (Faust, Garard, Gohlke) and pay a fee of \$25.
- 4. The grounds will be closed to practice at <u>6:00 p.m.</u> each day and all handlers and dogs will be off the grounds by 6:15 p.m.

Suggestions for increasing the amount of time available for practice in the field:

- stay quiet during roll call so it can be completed quickly;
- help beat brush to finish the trial in a timely manner;
- be available when it is time to run your dog during the trial or for Absolute

Subject to the above rules, practice on the grounds will be allowed on Thursday, October 1, 2020 after 12:00 noon until 6:00 p.m., on trial days after the conclusion of trials until 6:00 p.m., and non-trial days (Tuesday and Wednesday) from 8:00 a.m. to 6:00 p.m., unless the grounds are being used for another activity (which would be posted).

*Handlers with paid annual running grounds use privileges from NIBC may use the grounds any day they are open to practice with their rabbit tracking dogs, which may include breeds other than Dachshunds.

TRACKING COLLARS. The use of tracking collars will not be allowed at these trials.

WALKWAYS. Walkways will be marked in the camping areas. These walkways <u>must</u> be kept clear of campers, vehicles, x-pens, tables, chairs, etc. Every occupied camping unit must be accessible by emergency personnel.

Additional information may be posted in the clubhouse.

*To the extent applicable, these trials must comply with State of Illinois and Winnebago County Executive Orders and Ordinances, Private Campground Guidelines, and guidance provided by the American Kennel Club. In addition to those COVID precautions listed above, the following are also in effect:

- Please do not attend these trials If you have:
 - 1. a fever, cough or flu-like symptoms;
 - tested positive for COVID-19 and have not been free of fever without fever suppressing medication for 10 days;
 - 3. traveled internationally in the past month;
 - 4. been in direct contact with someone with COVID-19 in the past 14 days.
- "Illinois Executive Order 2020-32 requires any person over 2 years of age to wear a face
 covering when in a public place and unable to maintain a 6-foot social distance. Face
 coverings also are required in public indoor spaces, such as grocery or drug stores.
 Exceptions may be made for individuals with medical conditions or disabilities that prevent
 them from safely wearing a face covering."

Please bring/wear your own mask (disposable or cloth) when social distancing is not possible. Masks will be available in the clubhouse for those that need them.

- Adequate social distancing should be possible in most outdoor situations, such as beating brush, competing with dogs in the field and judging.
- Masks must be worn in the clubhouse, except when you are eating or drinking.
- Practice social distancing and avoid congregating to the extent possible.
- Hand sanitizer, disinfecting spray or wipes and soap for hand washing will be available in the clubhouse. A cold water hand washing station is also available outside.
- Avoid touching dogs that are not your responsibility.
- Weather permitting, roll call and bracing will be held outside to allow social distancing. Please bring your own pens and pencils. If you take a pencil from the clubhouse, do NOT return it. Bracing sheets will be provided.
- Weather permitting, ribbons and prizes will be available for pick-up outside (no awards ceremony). Handshaking and physical contact is discouraged.

CANINE GOOD CITIZEN TEST With AKC Licensed Evaluator: Pam Bethke

By appointment only. Schedule with Pam Bethke.

Entry fees: CGC \$15.00, CGCA or CGCU \$20.00 Make Checks payable to NIBC

Entries may be submitted on any AKC entry form, or the form included in this premium list.

Entries should clearly be marked "CGC TEST".

Before taking the Canine Good Citizen test, owners will sign the **Responsible Dog Owners Pledge**. Responsible dog ownership is a key part of the CGC concept and by signing the pledge, owners agree to take care of their dog's health needs, safety, exercise, training and quality of life. Owners also agree to show responsibility by doing things such as cleaning up after their dogs in public places and never letting dogs infringe on the rights of others.

Equipment

All tests must be performed on leash. Dogs should wear well-fitting buckle or slip collars made of leather, fabric, or chain. Special training collars such as pinch collars, head halters, etc. are not permitted in the CGC test. We recognize that special training collars may be very useful tools for beginning dog training, however, we feel that dogs are ready to take the CGC test at the point at which they are transitioned to regular collars.

The evaluator supplies a 20-foot lead for the test. The owner/handler should bring the dog's brush or comb to the test.

Encouragement

Owners/handlers may use praise and encouragement throughout the test. The owner may pet the dog between exercises. Food and treats are not permitted during testing, nor is the use of toys, squeaky toys, etc. to get the dog to do something. We recognize that food and toys may provide valuable reinforcement or encouragement during the training process but these items should not be used during the test.

Failures - Dismissals

Any dog that eliminates during testing must be marked failed. The only exception to this rule is that elimination is allowable in test Item 10, but only when test Item 10 is held outdoors.

Any dog that growls, snaps, bites, attacks, or attempts to attack a person or another dog is not a good citizen and must be dismissed from the test.

CGC Test Items:

Test 1: Accepting a friendly stranger

Test 2: Sitting politely for petting

Test 4: Out for a walk (walking on a loose lead)

Test 5: Walking through a crowd

Test 6: Sit and down on command and Staying in place

Test 7: Coming when called

Test 8: Reaction to another dog

Test 9: Reaction to distraction

Test 10: Supervised separation

CGCA Test:

AKC Community Canines[™] is the advanced level of the AKC's Canine Good Citizen Program. Dogs who pass the AKC Community Canine test earn the official AKC Community Canine title that is designated by the letters "CGCA" (Advanced CGC) on the dog's title record.

There is no age limit for dogs taking the AKC Community Canine test. However, before taking the test, dogs must have a Canine Good Citizen test on record at AKC.

To earn the CGCA title, the dog must:

- be registered or listed with AKC (AKC number, PAL, or AKC Canine Partners number) and,
- already have a Canine Good Citizen award/title on record.
- Dogs must pass all 10 items of the test to receive the CGCA title.
- 1. Dog stands, sits or lies down and waits under control while the owner:
- sits at the registration table and fills out paperwork, or,
- if the test is done in the community, dog waits while the owner sits and has a snack or visits with another person (e.g., at a park)
- 2. Walks on a loose leash in a natural situation (not in a ring) -- does not pull.
- left turn
- right turn
- stop
- fast and slow pace
- 3. Walks on loose leash through a crowd:
- at a show or in class, this item is tested in a real crowd, not in a ring
- in the community, dog walks on sidewalk, through a crowd at a community fair, park, on a trail, through a busy hallway, etc.
- Dog walks past distraction dogs present; does not pull. This item may be tested along with #3 if there are dogs in the crowd, etc.
- at a show or class, dog walks by dogs waiting in the crowd--dogs 2 ft. apart.
- in the community, dog walks by other dogs on a trail, sidewalk, in a hallway, etc.
- Sit -- stay in small group (3 other people with dogs). Owners and dogs are in an informal circle/square while owners have a conversation. Dogs are all on the owner's left side, on leash; 3 ft. apart. (At least 30 seconds).
- 6. Dog allows person who is carrying something (backpack, computer bag, etc.) to approach and pet it. "May I pet your dog?" (Item is placed on floor/ground before the person pets the dog).
- 7. "Leave it." Dog walks by food and follows owner instructions, "Leave it." This can be food placed by the evaluator on the floor or ground in a food dish with a wire cover as in Rally.
- Down or sit stay -- distance (owner's choice). Dog is on 20--ft line, owner walks away with back to
 dog, picks up an item (e.g., backpack, training bag, clipboard, folder etc.) placed on the
 floor/chair/ground by the evaluator and returns to the dog.
- Recall with distractions present (coming when called). Handler goes out 20--ft. **(off center) and calls dog. Dog is on the 20--ft. line from #8 above.
- Dog will sit or stand stay (owner's choice) while owner enters/exits a doorway or narrow passageway. Owner calls dog through door when ready. Owner may also choose to:
- send the dog through first and have the dog wait for the owner, or
- the owner may choose to have the dog go through the doorway at the owner's side.
 Whichever method is used, the dog must not pull the owner and must be under good control.
 Think of the handler having the leash in one hand and a cup of coffee in the other. Doorway or gate can be real or simulated with ring gates, two chairs, or a natural passageway (e.g., entrance to trail) in the community.

CGCU Test:

AKC Urban CGC is a title in the Canine Good Citizen family of awards and titles that also include AKC S.T.A.R. Puppy, Canine Good Citizen and AKC Community Canine.

AKC Urban CGC requires that the dog demonstrate CGC skills and beyond in an urban setting. As with Canine Good Citizen, AKC Urban CGC has a 10-step test of skills that dogs must pass to earn the official AKC Urban CGC title. This is a title that appears on the dog's title record at AKC.

To earn the CGCU title, the dog must:

- be registered or listed with AKC (AKC number, PAL, or AKC Canine Partners number) and,
- already have a Canine Good Citizen award/title on record.
- Dogs must pass all 10 items of the test to receive the CGCU title.
- Exit/enter doorway with no pulling in dog-friendly buildings. Exit building to start test, additional Public buildings items are below.
- 2. Walk through a crowd on a busy urban sidewalk.
- People come toward the dog from 1-ft. away
- Tolerate distractions (people wearing hats, coats, men, women, etc).
- 3. Appropriate reaction to city distractions. This includes movement, noises, and walking on a variety of surfaces. Examples:
- Noises: horns, sirens, construction noise, etc.
- Moving objects: skateboard, bike, carts, person running
- Surfaces: concrete, grass, grates, plastic tarp, wet sidewalk
- Crossing street: Stop at corner, stand or sit to wait and cross with no pulling (on leash, with owner).
 Crosses street under control.
- 5. Ignore food on sidewalk. (Dropped food, or cups, bags, cans, in which food was wrapped).
- Person walks up and pets the dog. May be carrying an item such as a small dog in a bag, a computer bag, etc. Person does not put the bag down to pet the dog.
- Public Building (that is dog friendly). Walks under control in building (slick surface, carpeted floor).
 Down stay (3 min) in lobby or outdoor area, or waits while owner has a meal or snack.
- 8. Stairs, steps, or elevator under control.
- Steps (at least 3 up and down)
- Elevator (Enters under control, exits, rides under control)
- Housetrained for apartment, condo, city living. Owner may verify this item. Evaluator may also observe in public buildings, or have observed in training classes.
- 10. Transportation. Owner's choice depending on transportation needs.
- Car. Enters/exits, remains under control during the ride. (Crate? Seatbelt?)
- Subway. Small dog in bag for ride. (large dogs are not always permitted; know and abide by the Transit Policies in your area).
- Dog friendly (enters/exits or allows to be put in/taken out) under control.

**As of January 1, 2013, Canine Good Citizen® became an official AKC title that can appear on the title records of dogs registered or listed with AKC. There is a \$20.00 processing fee, not included in the test fee, that the dog owner will pay to the AKC for CGC titles if they want them to appear on the dog's registration.

AKC Trick Dog titles are official AKC titles listed on the dog's title record. The processing fee for each title is \$20. Multiple titles for the same dog can be sent in together, each one will be processed in succession after each previous title has been added and printed. Dogs must have an AKC, PAL, or AKC Canine Partners number to earn a title.

The dog performs 10 skills from the Novice list. If a dog has a Canine Good Citizen (CGC) certificate or title on record at AKC, it can do 5 Novice tricks (CGC + 5) to earn the Novice title.
